RE: OHCQ Status Report on Implementation of QIS Process

OHCQ ADVANCES THE QUALITY INDICATOR SURVEY (QIS) PROCESS

OHCQ recently reported that two survey teams have completed their mock survey training and will begin surveys of record. By mid-May, OHCQ would like to have four surveyors trained for the remaining QIS Survey teams. In addition, OHCQ has formed an additional team of surveyors to perform traditional surveys, while teams are in QIS training, to maintain a twelve month overall average for recertification surveys. Nursing facilities listed below in the two survey teams (TEAMS TWO AND FOUR) can expect to receive a QIS Survey of Record if the survey falls within their survey window. *** Facilities in green indicate those facilities formerly surveyed by Team Three, which currently does not exist. These facilities have been redistributed into Teams Two and Four.

OHCQ RECRUITING FOR MOCK SURVEY SITES

OHCQ continues its recruiting efforts for mock survey sites. To qualify, volunteer facilities must have had their survey in the past six months and not be on an enforcement track. Interested facilities should contact Danna Kauffman at dkuffman@lifespan-network.org.

TRAINING OFFERED FOR PROVIDERS ON QIS PROCESS

LifeSpan and HFAM are currently offering basic training for providers to understand the principles of QIS as well as how your facility can prepare for a survey using the QIS process. Department Managers as well as administrators, corporate staff and consultants must understand this new process in order to be successful. It is important to note that the regulations have not changed, only the process by which your compliance with those regulations will be determined. THE 1-DAY BASIC COURSE details the QIS process used by state surveyors and teaches providers how the QIS tools and procedures can be used in their own quality assurance and improvement programs.
