As always, third party reimbursement systems continue to change. Some of the changes are minor and others will challenge the way operate your facility. As Skilled Nursing Facilities continue to experience changes in reimbursement formulas and theory, they face a new challenge as the State's arrangement with CMS (TCOC) now directly involves the post-acute providers. Average Length of Stay and Total Cost of Care will be the key factors controlling your Medicare Census. It's all about your data and how your hospital partners interpret that data. You need to know what those numbers mean and the formulas driving those calculations. And now your relationship with those agencies that you work with after discharge can be as important as your hospital partner relationships. Are you prepared?

In addition to the reimbursement implications, other changes have been implemented or, are on the way: Eligibility Systems, State Health Plan changes, Certificate of Need, MOU, New OHCQ regulations and the whole issue of what to do with the Dual Eligible Population.

FROM INTERSTATE 95

Take the MD-175 W EXIT 41, toward Columbia. Merge onto MD-175 W/Rouse Pkwy. Turn slight right onto ramp to merge onto Columbia Gateway Dr. Follow approximately 1.5 miles to a left onto Samuel Morse Dr. *(If you reach Robert Fulton Dr. you've gone too far)*. 7090 is on the right and at the end of Samuel Morse Drive. Turn towards the office building. Follow the signs to go left around the building to the Handelman Conference Center. **The Conference Center is at the rear of the building.**

FROM ROUTE 32

Take Exit 14 for Broken Land Pkwy. Merge onto Broken Land Pkwy. Turn right onto Snowden River Parkway. Immediately after the light at Oakland Mills Rd. use the right lane to take the ramp onto Robert Fulton Drive.
